

## Shooting 4 Greatness Academy Enrollment Contract

Both parents, guardians, and other persons responsible for payments should read all the provisions of this Contract, complete the required information, sign and return the Contract to Shooting 4 Greatness Academy "S4G" accompanied by a non-refundable Registration fee of \$400. A student-athlete is accepted for enrollment when the Contract has been executed and down payment has been paid. A copy of the accepted Contract will be returned for the responsible parties' records. No amendment to this Contract and no alteration or addition to the printed terms hereof will be effective without the express prior written approval of the Academy.

In consideration of the acceptance of this Contract by the Academy, the undersigned agrees to pay the required TOTAL TUITION for the full program year and any additional fee incurred and agrees to be bound by the provisions of this Contract. So long as tuition and fee payments are not delinquent, tuition payments are due no later than the date listed within this Contract.

### **Enrollment is conditioned upon the following terms:**

\_\_\_\_ 1. A non-refundable Registration Deposit of \$400 must accompany the Contract and a down payment. The first month's tuition is due on or before the 1<sup>st</sup> day of September. Tuition payments must be received by the Academy on or before each due date.

\_\_\_\_ 2. *Acceptance of enrollment constitutes an agreement to pay the full program year's account, comprised of both TOTAL TUITION and all related fees and expenses of the student. The Academy is entitled to be reimbursed for any attorney's fees and costs incurred in the collection of any unpaid balance.*

\_\_\_\_ 3. The student and the student's family agree to comply with and be subject to the Academy's rules and policies as set forth in the Academy's rules and guidelines, as amended from time to time.

\_\_\_\_ 4. An account is considered delinquent if not paid within 5 business days of the due date. A late payment fee of \$50 will be charged on a delinquent account. Whenever a tuition account becomes past due for a period of 60 days from its due date then, unless the Academy shall obtain adequate security acceptable to the Academy for such account within that 60 day period, the student will be dismissed from the program. In all events, the first tuition installment payment must be paid on or before the first day of September or the student's place will not be reserved. The student will not be enrolled in the program.

\_\_\_\_ 5. Upon Withdrawal or Dismissal from the program, the tuition for the remainder of the program year will be charged and due upon demand.

\_\_\_\_ 6. The terms and provisions on the reverse side of this Contract must be completed and are included as part of this Contract by reference.

**WAIVER OF LIABILITY:** It is expressly agreed that the participation by \_\_\_\_\_ in Shooting 4 Greatness Academy's program, including but not limited to basketball and class shall be undertaken at their own risk. S4G, its servants, agents and employees shall not be liable for any claims, demands, injuries, damages, actions or causes of action whatsoever to us or our child or our property or our child's property arising out of, or connected with our child's being at S4G. We do hereby expressly forever release and discharge S4G, its agents, employees, and trustees from all such claims, demands, injuries, damages, actions or causes of action, and from all acts of active passive negligence on the part of S4G, its agents, employees, or trustees.
